Dr. Samia Costandi is a Canadian of Palestinian origin who was born in Cyprus and grew up in Lebanon. In 1988 she travelled with her two sons, Khaled, aged 10, and Omar, aged 8, to Montreal to pursue her masters and then her doctorate at McGill University in the Faculty of Education. She made Canada her country of choice and obtained her citizenship in 1997. Dr. Costandi has twenty five years of teaching experience in higher education. She taught at McGill Faculty of Education from 1990-2001 as well as at several colleges in Montreal; she has extensive experience in teacher training. She holds the Margaret Gillett Award from the Centre for Research & Teaching on Women at McGill University (2000); she also obtained the Helen Prize for Women (1999) for merging her academic work with her community work in Motreal; while engaging in her doctoral research she was one of fifty select researchers who held the most prestigious Quebec Government Doctoral Award FCAR for the academic years 1997-1998 &1998-1999/

Dr Costandi joined Ahlia University in 2009 and is a passionate teacher, a prolific writer, a rigorous researcher, and a committed educator whose mentoring has inspired many students over the years including Ahlia students whom she inspired to establish the Psychology Club at Ahlia University during the past year; she believes in student centered learning, interdisciplinary research as well as life-long learning that is embedded in community work. Dr. Constandi teaches in the areas of *philosophy of education* and *the humanities*; among the courses she has taught over the years are: *Philosophical Foundations of Education, Multicultural Education, Mythology in Education, Introduction to Psychology, Introduction to Sociology, Culture, Drama & Education, Education Biography, Introduction to Educational Psychology, Ethics in Practice, World Views, Classroom Management, Contemporary Issues in Education and many others.*
